#### RECOGNITION ORDER

**AND WHEREAS**, in exercise of the powers conferred by sub-section(2) of Section 32 of the National Council for Teacher Education Act, 1993 (73 of 1993), and in supersession of the National Council for Teacher Education [Recognition Norms and Procedure] Regulations, 2009, the National Council for Teacher Education notified the Regulations, 2014 on 1.12.2014.

**AND WHEREAS**, on scrutiny/perusal of the application submitted by the institution, the documents attached therewith, the affidavit, and the input received from the visiting team in the form of report and videography, recommendation of the State Government, the Committee in its **254<sup>th</sup> meeting held on June 7-9, 2016** was satisfied that the institution/society fulfils the requirements under the provisions of NCTE Act, Rules and relevant Regulations including the Norms and Standards for the **D.El.Ed.** programme, such as infrastructural and instructional facilities, library, accommodation, financial resources, laboratory etc. for running the programme and has selected/appointed duly qualified teaching staff as per NCTE norms.

**NOW, THEREFORE**, in exercise of the powers vested under Section 14(3)(a) of the NCTE Act, 1993 and in accordance with the Regulations, 2014, the Western Regional Committee, NCTE hereby grants recognition to **HAJRA MEMORIAL COLLEGE, RUN BY HAJRA EDUCATION AND WELFARE SOCIETY, PLOT/KHASRA NO.607, VILLAGE - MALHARGARH, POST OFFICE/TEHSIL/TALUKA/TOWN/CITY - KHALWA, DISTRICT - KHANDWA (EAST NIMAR), PIN CODE - 450117, MADHYA PRADESH** for conducting **D.El.Ed.** programme of 2 (Two) years duration with an annual intake of 50 students (**one basic unit**) from the academic session **2017-2018**.

The institution shall submit to the Regional Committee a Self- Appraisal Report at the end of each academic year along with annual statement of accounts duly audited by a Chartered Accountant.

- The affidavit with enclosure submitted along with application.
- The institution shall be free to post additional relevant information, if it so desires.
- Any false or incomplete information on website shall render the institution liable for withdrawal of recognition.
